

Several unique vaccines developed for the first time in the world, such as Theileriosis vaccine for cattle, combination vaccines with Foot and Mouth Disease (FMD), Porcine Cysticercosis vaccine. For the first time in India, III. introduced Brucellosis vaccine, Blue Tongue vaccine, gE deleted IBR marker vaccine, 7 in 1 canine vaccines etc which are well accepted in the Indian market. IIL's research team are working on several new animal health vaccines viz, multi-component Clostridia vaccine, Lumpy skin Disease, Mastitis vaccine, Fish Vaccines etc. In human health segment, IIL is working on Chikungunya vaccine, Typhoid vaccine, Zika, Rota Virus, Dengue, and monoclonal antibodies (mabs) etc. MR and Td vaccines have been licensed.

## MANUFACTURING CAPABILITIES

IIL is the largest animal vaccine manufacturer in Asia. IIL's two vaccine manufacturing facilities located in Hyderabad. The Gachibowli-Hyderabad facility is engaged in the production of animal and human health vaccines, while the Karakapatla-Hyderabad facility produces animal health formulations and will also produce human vaccines shortly. IIL's Ooty facility exclusively produces human anti-rabies vaccine, "Abhayrab". Apart from this, IIL also operates Pristine Biologicals in New Zealand which processes bovine serum for use in vaccine making, complimenting India's self-sufficiency in the field of vaccines. Another new animal vaccine facility is coming up in Karakapatla, Hyderabad. IIL has been able to develop Covid Drug Substance in record time to augment national demand. This was possible due to sheer technical competence of IIL to develop and deliver Covid drug substance within four months.



## LEADERSHIP POSITION



IIL enjoys the leadership position in its animal health vaccines segment. IIL's human anti-rabies vaccine (Abhayrab) is the largest selling brand in India and established its leadership position in several countries in Asia. Abhayrab is the first tissue culture rabies vaccine indigenously developed in India and it's only second only in the world. IIL exports its products to more than 50 countries. IIL's flagship brands,

Raksha-Ovac (FMD vaccine) is one of the largest selling brands in Animal Health market. This is besides several other leading products such as Raksha-Class (CSF vaccine), Raksha-Goat Pox, Rakshavac-T

(Theileriosis), Raksha-SP (Sheep Pox) and several other vaccines for small and large ruminants. Abhayrab (Human anti-rabies vaccine) is a brand leader with sales close to Rs. 500 Cr in 2024-25. IIL is also one of the largest suppliers of animal and human vaccines to Animal Husbandry departments of various state governments and to the Universal Immunisation programme (UIP) of Ministry of Health, Government of India.

IIL markets its animal health products in dairy milk shed areas, promotes its products to the Veterinarians, paravets etc with various communication tools such as rural campaigns, seminars, digital campaigns etc. IIL also promotes its animal health products to various institutions such as state and central government agencies and various governments in several countries in the international market. IIL's human health products are promoted to various medical practitioners and hospitals through direct and digital campaigns.

# NEW INITIATIVES

IIL is expanding its capacities and establishing new viral vaccine production facility in Karakapatla, Hyderabad. This besides its new lyophilized unit which will give higher output for vaccines such as CSF, Brucellosis and several canine

vaccines. A new Greenfield facility for manufacture of FMD vaccine is underway in Karakapatla, Hyderabad, besides another Bovine Serum facility in Australia.

#### FARMER FIRST

IIL shares NDDB's philosophy in reaching out to the farmers and consumers. Several initiatives or farmers' outreach programmes such as Farmers Contact Programme (FCP), Video-on-Wheels (VOW) programme, Cattle Fairs, Knowledge Upgradation Programme, Mass Vaccination Camps (MVC), Ration Balancing Programme (RBP), Shepherd Contact Programme have immensely benefited the livestock growers.

#### CORPORATE SOCIAL RESPONSIBILTY



As a part of its Corporate Social Responsibility (CSR), IIL has adopted several schools and provided



infrastructure and nutritional supplements through NDDB's NFN programme. IIL's "Gou-Raksha" project serves as boon to several destitute animals in various Goshalas and Pinjrapole societies. This project is aimed at providing free vaccination and deworming coverage to all these destitute animals. Another important initiative- "Go Green", a biogas plant for conversion of dung into fertilizer is provided as assistance to villages for self-sustenance (part of NDDB initiative). Other important initiatives include – "Utkarsh- Rabies control in Maharashtra"; "Rabies Free Thiruvananthapuram"; "Rural electrification in Muzaffarnagar": Oxygen Plant – for Covid patients in Telangana Institute of Medical Sciences"; "CCTV Cameras- in Siddipet" etc.

#### **NEW PRODUCTS**

Since 2016, IIL introduced several animal health vaccines such as ET+TT (Enterotoxaemia and Tetanus) for sheep and goats, Tinea Solium (Vaccine against Porcine Cysticircosis), Raksha-CSF (Classical Swine Fever) vaccine, Raksha Goat Pox (Goat Pox) vaccine, Raksha-IBR (IBR) vaccine etc. In human health, IIL got license to manufacture Pentavalent Vaccine (5 in 1) for children to be used under Universal Immunization Programme of Government of India; first indigenously developed Hepatitis A vaccine in India. MR and Td vaccine being licensed recently.
